

INVITATION FOR BIDS

Town of Mendon, VT

Wheelerville Road Culvert 07-61 Replacement Project

Sealed bids from qualified contractors shall be accepted until **2:00 PM** prevailing time on June 4, 2019 at the Mendon Town Offices, 2282 U.S. Route 4, Mendon, VT 05701, for construction of the project hereinafter described. Bid opening will occur immediately after the bid submittal deadline. The time of receiving and opening bids may be postponed due to emergencies or unforeseen conditions.

Sealed BIDS shall be marked in the lower left hand corner: **Bid Documents: Wheelerville Road Culvert 07-61 Replacement Project, Mendon, Vermont.**

All bids must be accompanied by: a negotiable bid guarantee which shall not be less than five percent (5%) of the amount of the bid, a completed Debarment and Non-Collusion Affidavit, and a signed Contractors Equal Employment Certification Form.

LOCATION: The project is located along Wheelerville Road approximately 0.6 miles north of its intersection with Notch Road.

TYPE OF CONSTRUCTION: Work to be performed under this project includes: loading of riprap and stonefill, transport to the project site, site preparation, including removal of loose, woody and deleterious material, removal of culvert, installation of CMP arch pipe, installation of headwall and wingwalls, machine placement and compaction of riprap, stonefill, filter base and other granular material, road subbase and base material, temporary stream diversion, road subbase and road surface course aggregate and incidental items.

CONTRACT COMPLETION DATE: The project is intended to begin in July 2019 and shall be completed on or before **September 13, 2019**. Closure of Wheelerville Road to through traffic shall not exceed three weeks duration.
