City of Rutland, VT (Owner) is requesting Bids for the construction of the following Project:

Grove Street Bridge Rehabilitation

Sealed Bids for the construction of the Project will be received electronically by the City of Rutland, VT at [saram@rutlandcity.org](mailto:saram@rutlandcity.org) until 4:00 PM local time on, Tuesday, June 8, 2021.

Bids submitted after this time will not be accepted. Bids shall be submitted electronically with the email subject line: "Grove Street Bridge Rehabilitation". The bids will be publicly opened and read at the June 9<sup>th</sup> Board of Finance Meeting at 3:00 PM.

The proposed Project may include but is not necessarily limited to: Rehabilitation of the existing bridge (Bridge No. 25) including concrete substructure repairs (partial reconstruction of the southern abutment ends and repairs to the south pier cap), bearing replacements and replacement of the southern deck expansion joint. Shoring of the existing superstructure will be required during repairs.

Owner anticipates that the Project's total bid price will be below \$250,000.00 with an expected duration of 120 days.
