

INVITATION FOR BIDS

Town of Duxbury, VT

Scrabble Hill Road Culvert Replacement Project

Sealed bids from qualified contractors shall be accepted until **3:00 PM** prevailing time on June 10, 2021 at the Duxbury Town Office, 5421 VT Route 100, Duxbury, VT 05676, for construction of the project hereinafter described. Bid opening will occur June 10, 2021 directly after bids are due. Contractors will be notified of the Selectboard's decision after their scheduled meeting on June 14, 2021. The time of receiving and opening bids may be postponed due to emergencies or unforeseen conditions.

Sealed BIDS shall be marked in the lower left hand corner: **Bid Documents: Scrabble Hill Road Culvert Replacement Project, Duxbury, Vermont.**

All bids must be accompanied by: a negotiable bid guarantee which shall not be less than five percent (5%) of the amount of the bid, a completed Debarment and Non-Collusion Affidavit, and a signed Contractors Equal Employment Certification Form.

LOCATION: The project is located along Scrabble Hill Road approximately 0.5 miles east of Camels Hump Road. GPS Coordinates N 44.331125, W 72.827920.

TYPE OF CONSTRUCTION: Work to be performed under this project includes: site preparation, including removal of loose, woody and deleterious material, removal of existing culvert & delivery of pipe to the Duxbury gravel pit (unless another location is coordinated with the Town), common and solid rock excavation (if necessary), furnishing and installing fabric and bedding for the culvert, coordination with the Town and precast structure supplier to unload and install the delivered precast structures (including the culvert sections, headwalls, wingwalls, cutoff walls, and retention sills), furnishing, machine placement and compaction of riprap and stone fill, stonefill, filter base and other granular material, road subbase and base material, temporary stream diversion, furnishing and installation of an 18" diameter driveway culvert, and incidental items.

CONTRACT COMPLETION DATE: The project is intended to begin after July 1, 2021 and shall be completed on or before **October 1, 2021**. Traffic control and closure of Scrabble Hill Road shall be coordinated with the Town of Duxbury.
