This Addendum forms part of the Contract Documents and modifies the original Bidding Documents issued by the Tioga County Soil and Water Conservation District, for the Fuller Hollow Creek Stream Stabilization Project Lower Dam Removal Project dated April 30, 2021. **Acknowledge receipt of this Addendum in the space provided on Page 1 of the Bid Form. Failure to do so will subject the Bidder to disqualification.**

I. Pre-Bid Meeting

A Non-Mandatory Pre-Bid meeting was held at the Project Site on July 2, 2021 at 1:00 p.m. Attendees are listed on the attached Pre-Bid Meeting Attendance Log. Andrew Hoak, PE, of DuBois & King, Inc. described key elements of the project. The following addresses questions received at the pre-bid meeting, as well as subsequent questions from prospective bidders.

II. Questions & Answers

Question 1. Would Tioga County SWCD like to retain any of the excess streambed material for use on a future project?

Answer 1. No. The contractor will be responsible for the identification of a suitable disposal site for the material (subject to review and approval by USACE) and disposal of all materials. No streambed material will be retained by TCSWCD.

Question 2. Has access through Stair Park from Murray Hill Road been confirmed and approved by the Town of Vestal?

Answer 2. The Town of Vestal is still considering this option

Question 3. Is it possible to delay the start of construction until the Washington Drive bridge work is completed during the month of August?

Answer 3. TCSWCD is agreeable to delay the start of construction to no later than September 1, 2021.

Question 4. Will a video conference call be available to bidders for the bid opening?

Answer 4. DuBois & King will provide a video conference link to all plan holders in advance of the bid opening registered at <https://www.dubois-king.com/projects-bidding-active/>

Question 5. For the maintenance of the vegetation plantings if we mobilize out to the site to water and maintain is that a prevailing wage rate?

Answer 5. Yes, prevailing wage rates apply to installation and maintenance of vegetative plantings at the project site as it is part of the overall construction effort.

Note: Executive Order (EO) 13706, Establishing Paid Sick Leave

for Federal Contractors applies to all contracts subject to the Davis-Bacon Act for which the contract is awarded (and any solicitation was issued) on or after January 1, 2017. If this contract is covered by the EO, the contractor must provide employees with 1 hour of paid sick leave for every 30 hours they work, up to 56 hours of paid sick leave each year. Employees must be permitted to use paid sick leave for their own illness, injury or other health-related needs, including preventive care; to assist a family member (or person who is like family to the employee) who is ill, injured, or has other health-related needs, including preventive care; or for reasons resulting from, or to assist a family member (or person who is like family to the employee) who is a victim of, domestic violence, sexual assault, or stalking. Unlisted classifications needed for work not included within the scope of the classifications listed may be added after award only as provided in the labor standards contract clauses (29CFR 5.5 (a) (1) (ii)).

The body of each wage determination lists the classification and wage rates that have been found to be prevailing for the cited type(s) of construction in the area covered by the wage

determination. The classifications are listed in alphabetical order of ""identifiers"" that indicate whether the particular rate is a union rate (current union negotiated rate for local), a survey rate (weighted average rate) or a union average rate (weighted union average rate).

Union Rate Identifiers

A four letter classification abbreviation identifier enclosed in dotted lines beginning with characters other than ""SU"" or ""UAVG"" denotes that the union classification and rate were prevailing for that classification in the survey. Example:

PLUM0198-005 07/01/2014. PLUM is an abbreviation identifier of the union which prevailed in the survey for this classification, which in this example would be Plumbers. 0198 indicates the local union number or district council number where applicable, i.e., Plumbers Local 0198. The next number, 005 in the example, is an internal number used in processing the wage determination. 07/01/2014 is the effective date of the most current negotiated rate, which in this example is July 1, 2014.

Union prevailing wage rates are updated to reflect all rate changes in the collective bargaining agreement (CBA) governing this classification and rate.

Survey Rate Identifiers

Classifications listed under the ""SU"" identifier indicate that

no one rate prevailed for this classification in the survey and the published rate is derived by computing a weighted average rate based on all the rates reported in the survey for that classification. As this weighted average rate includes all rates reported in the survey, it may include both union and non-union rates. Example: SULA2012-007 5/13/2014. SU indicates the rates are survey rates based on a weighted average calculation of rates and are not majority rates. LA indicates the State of Louisiana. 2012 is the year of survey on which these classifications and rates are based. The next number, 007 in the example, is an internal number used in producing the wage determination. 5/13/2014 indicates the survey completion date for the classifications and rates under that identifier.

Survey wage rates are not updated and remain in effect until a new survey is conducted.

Union Average Rate Identifiers

Classification(s) listed under the UAVG identifier indicate that no single majority rate prevailed for those classifications; however, 100% of the data reported for the classifications was union data. EXAMPLE: UAVG-OH-0010 08/29/2014. UAVG indicates that the rate is a weighted union average rate. OH indicates the state. The next number, 0010 in the example, is an internal number used in producing the wage determination. 08/29/2014 indicates the survey completion date for the classifications and rates under that identifier.

A UAVG rate will be updated once a year, usually in January of each year, to reflect a weighted average of the current negotiated/CBA rate of the union locals from which the rate is based.

WAGE DETERMINATION APPEALS PROCESS

1.) Has there been an initial decision in the matter? This can be:

- * an existing published wage determination
- * a survey underlying a wage determination
- * a Wage and Hour Division letter setting forth a position on a wage determination matter
- * a conformance (additional classification and rate) ruling

On survey related matters, initial contact, including requests for summaries of surveys, should be with the Wage and Hour Regional Office for the area in which the survey was conducted because those Regional Offices have responsibility for the Davis-Bacon survey program. If the response from this initial contact is not satisfactory, then the process described in 2.) and 3.) should be followed.

With regard to any other matter not yet ripe for the formal

process described here, initial contact should be with the Branch of Construction Wage Determinations. Write to:

2.) If the answer to the question in 1.) is yes, then an interested party (those affected by the action) can request review and reconsideration from the Wage and Hour Administrator (See 29 CFR Part 1.8 and 29 CFR Part 7). Write to:

Certification Pursuant to Section 103-g
Of the New York State

- A. By submission of this bid/proposal, each bidder/proposer and each person signing on behalf of any bidder/proposer certifies, and in the case of a joint bid, each party thereto certifies as to its own organization, under penalty of perjury, that to the best of its knowledge and belief that each bidder is not on the list created pursuant to paragraph (b) of subdivision 3 of Section 165-a of the New York State Finance Law.
- B. A Bid/Proposal shall not be considered for award, nor shall any award be made where the condition set forth in Paragraph A above has not been complied with; provided, however, that in any case the bidder/proposer cannot make the foregoing certification set forth in Paragraph A above, the bidder/proposer shall so state and shall furnish with the bid a signed statement which sets forth in detail the reasons therefor. Where Paragraph A above cannot be complied with, the Purchasing Unit to the political subdivision, public department, agency or official thereof to which the bid/proposal is made, or his designee, may award a bid/proposal, on a case by case business under the following circumstances:
1. The investment activities in Iran were made before April 12, 2012, the investment activities in Iran have not been expanded or renewed after April 12, 2012, and the Bidder/Proposer has adopted, publicized and is implementing a formal plan to cease the investment activities in Iran and to refrain from engaging in any new investments in Iran; or
 2. The political subdivision makes a determination that the goods or services are necessary for the political subdivision to perform its functions and that, absent such an exemption, the political subdivision would be unable to obtain the goods or services for which the contract is offered. Such determination shall be made in writing and shall be a public document.

GOSR Pre-Bid Meeting Talking Points

Elation Systems.

1. This CDBG-DR, HUD-funded project is subject to compliance reporting via Elation Systems.
2. Elation Systems is a web-based system which users can access via web browser. All vendors are required to register in Elation to complete compliance reporting as well as certified payroll reports. Required quarterly reporting captures vendors' payment, EEO and Section 3 activity, as well as M/WBE participation.
 - a. All vendors, including all construction and professional services subcontractors, must register, with the exception of suppliers.
 - i. All vendors will need a DUNS # to register
 - ii. If a supplier is an M/WBE, the vendor must only register to complete reporting if there is more than one purchase order for the project. If the M/WBE supplier was utilized for one purchase order, no registration is required, but a one-time paper ADM-146 report must be completed and uploaded to Elation by the prime contractor.
3. Reports are due quarterly for the length of each vendor contract. There are between two and seven compliance reports required of all participants, depending on the type of vendor and level of participation.
 - a. There are 5 reports required of prime contractors, and an additional two if the prime contract exceeds the Section 3 threshold of \$100k.
 - b. Depending on the amount of the contract and MWBE status, there are between 2 and 4 reports required of subcontractors.
 - c. There is one report required of MWBE suppliers utilized via a single purchase order
 - d. There are three reports required of MWBE suppliers utilized via multiple purchase orders.
4. All vendors will need to complete Certified Payroll Reporting as well.
5. Please note that Certified Payroll's and compliance reporting must be current for vendor invoices to be paid.
6. The team at GOSR offers training on the use of Elation to all vendors via phone call, webinar, or in-person scheduled sessions as preferred, and is also available to troubleshoot Elation issues as they arise, whether those issues concern compliance reporting or general use of the system.
 - a. GOSR staff will set up the project in Elation and push 'live' once the prime contractor is registered. OM will from there assist with further project setup, including ensuring all subcontractors are assigned to the project.
 - b. Manuals are available for vendor use
 - c. Troubleshooting assistance available business hours Monday through Friday

Labor Standards and Payroll Reporting.

1. Project subject to both federal and state prevailing wages, contractors must pick the higher of the two rates.
2. As mentioned in previous category, certified payrolls are submitted in Elations.
3. Contractor is to trickle down all the provisions in subcontracts.
4. All apprentices must be in approved DOL programs.

Diversity Compliance Resource Guide

1. Minority and Women Owned Business Enterprise (M/WBE)

Contractors must comply with Federal and State requirements pertaining to M/WBE utilization. Contractors must make a commitment and demonstrate an acceptable "Good Faith Effort" toward achievement of GOSR's M/WBE utilization goal of 15% MBE and 15% WBE.

- a. Search the NYS MWBE Directory. Directly solicit quotations for work available.
- b. Create an account on GOSR's Opportunity Portal and post a listing of the work required.
- c. Create an account on the NYS Contract Reporter system and list opportunities.
- a. Ensure that you record all responses received along with your evaluation.

2. Section 3

Contractors must comply with Federal and State requirements pertaining to Section 3 utilization. Compliance with Section 3 utilization requires Contractors to the greatest extent feasible, meet the following goals:

- a. At least 30% of new employees hired are Section 3 residents which applies to both construction and non-construction projects;
- b. At least 10% of the total dollar amount of all Section 3 covered contracts for housing rehabilitation, housing construction and public construction should be granted to eligible Section 3 businesses; and
- c. At least 3% of the total dollar amount of non-construction contracts should be granted to eligible Section 3 businesses.

Resources to assist with Section 3 compliance:

- a. Utilize the Section 3 search portal: to reach out to Section 3 firms with potential subcontracting opportunities.
- b. Maintain a log of all contacts with Section 3 firms in case opportunities develop over the life of the contract.
- c. Advertise opportunities for Section 3 participation on the GOSR Opportunities Portal and through the NYS Contract Reporter.

After all M/WBEs have been identified for utilization on the project, determine if these M/WBE firms also qualify as Section 3. Request that the subs fill out the Certification for Businesses Seeking Identification as Section 3 and that their employees fill out the Certification for Individuals Seeking Identification as Section 3.
