**INVITATION TO BID**  
**Chroma Technology Corporation, Inc. Slope Stabilization & Stormwater Improvements**

Sealed bids from pre-qualified contractors shall be accepted until 3:00pm, prevailing time on Friday, August 26 at 10 Imtec Lane, Bellows Falls, VT 05101, for construction of the project hereinafter described. Bid opening will occur immediately after the bid submittal deadline. The time of receiving and opening bids may be postponed due to emergencies or unforeseen conditions.

Sealed BIDS shall be marked in the lower left hand corner: Bid Documents: Chroma Technology Corporation, Inc.

Each BID must be accompanied by a certified check payable to Chroma Technology Corporation, Inc. (or Local Project Sponsor) for five percent (5%) of the total amount of the BID. A BID bond may be used in lieu of a certified check.

**LOCATION:** Beginning at a point on 10 Imtec Lane in Bellows Falls. Work includes slope stabilization, stormwater outfall improvements, plunge pool installation, and stormwater treatment system installation at the Chroma Technology Corporation, Inc. (Chroma) site. The project will take place on lands owned by Brattleboro Development Credit Corporation and Automatic Drive, LLC.

**TYPE OF CONSTRUCTION:** Work to be performed under this project includes: The removal of trees and stumps, common excavation of slope materials. Regrading and placement of erosion control matting, stone rip rap toe protection, replacement of stormwater outfall, plunge pool installation, stormwater pond removal, and installation of proprietary stormwater treatment system.
