Newhall Road Bridge Replacement over Green Brook

Sealed Bids for the construction of the Project will be received at the Town of Wells Town Managers Office, at the office of Marianne Goodine, Executive Assistant, 208 Sanford Road, Wells, Maine 04090, until **2:00 PM** local time on, **Friday, April 21, 2023**. At that time the Bids received will be publicly opened and read.

The Project includes the following Work:

Total removal of the existing concrete, steel and stone bridge (superstructure and substructure), construction of new bridge elements (precast prestressed deck panels, precast abutments, wingwalls and approach slabs and cast-in-place concrete deck topping and subfooting), bridge rail and approach rail, earthwork, drainage and approach roadway work.

Bids are requested for the following Contract:

Newhall Road Bridge Replacement over Green Brook

Owner anticipates that the Project's total bid price will be approximately between \$500,000.00 and \$550,000.00. The Project has an expected duration of 60 days.
