- C. Some details say galvanized and black vinyl coated separately, which is it? Handrails are to be powder-coated black.
- **D. What are the permitting requirements?** The contractor is responsible for obtaining a building permit for this project. No other permits are required.

Remove existing loading dock and the pavement surrounding it. Replace with new loading dock, subbase materials, and pavement.
