

ADVERTISEMENT FOR BIDS

18 MILE CREEK GOLF COURSE IRRIGATION SYSTEM IMPROVEMENT PROJECT

Separate sealed BIDS for the **18 Mile Creek Golf Course Irrigation System Improvement Project** will be received by the Town of Hamburg, Town Clerk's Office, 6100 South Park Avenue, Hamburg, NY 14075 until **September 29, 2023 at 3:00 pm.**

This project involves the installation of a new water intake (wet well) from 18 Mile Creek and rehabilitation of an existing irrigation pond along Neuman Creek. The project will also include re-establishment of the historical water course and streambanks as shown on the Engineering Drawings along with modification of the existing control building and installation of a new control panel and sprinkler heads. The project address is 6374 Boston State Rd, Hamburg, NY.

The specific objectives of the project include:

- Reduce erosion and sediment contribution to downstream reaches
- Provide a more reliable water source for the existing irrigation system; and
- Stabilize stream banks.
