Provide coating system as outlined in Steel Note 6 on Sheet Number 2.

QUESTION 4:

Specifications call for hot-dipped galvanized bolts, nuts and washers; is this applicable to the expansion joint?

All bolts and hardware material grade and corrosion protection shall be as specified by the joint manufacturer to achieve the specified design strength and joint service life.
