The Town of Littleton (Owner) is requesting Bids for the construction of the following Project:

Dells Pond Outlet Dam Improvements Project

Bids for the construction of the Project will be received at the **Littleton Department of Public Works & Highway Department** located at **28 Boynton Lane, Littleton, NH 03561**, until **Wednesday, August 27, 2025**, at **2:00 P.M.** local time. At that time the Bids received will be **privately** opened and read.

The Project includes the following Work:

Construction of improvements to an earthen dam involving demolition and excavation of an existing vehicular bridge, pond sediment dredging, installation of new pond drain system, granite wall spillway construction, a pedestrian steel bridge and concrete abutments, and other dam related improvements.

Bids are requested for the following Contract: **Dells Pond Outlet Dam Improvements Project**

Owner anticipates that the Project's total bid price will be approximately **\$500,000**. The Project has an expected duration of **90** days.
