III. ADDITIONAL INFORMATION OR CLARIFICATION

Note that some questions are paraphrased based on emails and those occurring during the pre-bid meeting.

- Are Davis-Bacon Wage Rates Required?
 Response: Davis-Bacon wage rates are not required.
- Are there any posted bridges in the vicinity of the project?
 Response: The Town noted that there are no posted bridges within the vicinity of the project.
- 3. What is the period of time available for de-energizing the overhead electric? Response: Eversource requires 8 weeks notice prior to de-energizing the overhead electric which crosses Jacobs Brook. De-energizing the line requires a backfeed of power along a non winter maintained roadway thus de-energizing is limited to times outside of December 10th to April 10th.

4. The contract calls for shear connectors; however, we did not see where they are subsidiary to an item. Was the item left out or is there a certain item on the bid item list that it is, in fact, subsidiary to?

Response: This will be subsidiary to 550.1. See Sheet No. 6 revisions in this addendum.

5. Is the intent to issue the Notice to Proceed as soon as the contract is signed or will the Notice to Proceed be issued in the Spring?

Response: The intent is to issue NTP in spring. See response to question no. 10.

6. Will pre-bid meeting minutes be provided?

Response: No pre-bid meeting minutes were developed. Attached for reference was the pre-bid meeting agenda. Questions brought up in the pre-bid meeting are incorporated in responses in this addenda.

7. What is the reg'd bid bond %?

Response: A bid security of 5 percent is required. See Instruction to Bidders for Construction Contract, Article 8 – Bid Security, 8.01

8. What is the anticipated schedule?

Response: Project has an expected duration of 240 days from Notice to Proceed. Closure of Archertown is limited to 200 days after April 1st.

9. Are any Addenda anticipated?

Response: No additional addendum beyond this one are anticipated.

10. Is there anything in the works for utility relocation?

Response: No existing utilities are being relocated. Overhead utilities will remain in place with electric being de-energized. See response to question no. 3.

11. Will D&K be doing the construction inspection? Or will it be another company?

Response: Wright-Pierce is anticipated to be performing construction observation services on the Town's behalf.
